New Business: It was restated that any preparations necessary for the June 14 Fun Fly will be addressed at the June 11 meeting at the MARCS airfield.

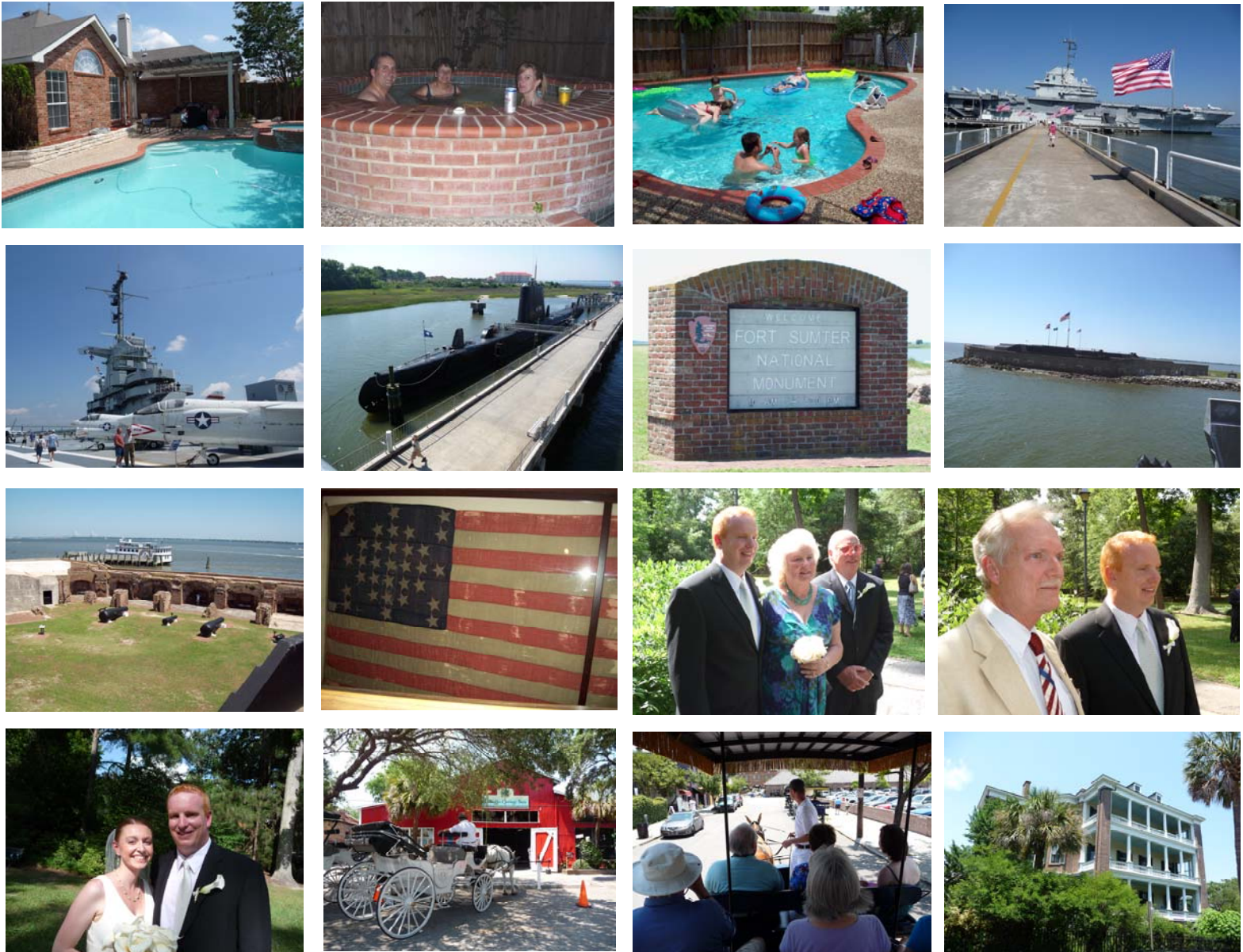
